## Cal Poly launches philanthropic foundation; former Foundation now Cal Poly Corporation

A new auxiliary organization, named the Cal Poly Foundation, has been created to lead campus philanthropic activity and manage endowments and investments. The new Cal Poly Foundation will focus on fund raising and asset management, according to Sandee Ogren, vice president of university advancement and CEO of the new Foundation. The former Cal Poly Foundation has been renamed the Cal Poly Corporation, or CPC. It retains many of the same leadership and functions that it had before, including El Corral Bookstore, Campus Dining, Mustang Graphics, University Graphics Systems and Sponsored Programs administration. The new Cal Poly Foundation has taken over management of endowment and gift funds and will contract with the CPC for accounting and endowment administration services.
