## Paid leave for Katrina relief work allowed

The CSU, in consultation with all of its unions, has implemented provisions that provide CSU employees with up to 10 days of paid administrative leave through **June 30, 2006**, if they are requested by a bona fide relief organization or governmental agency to assist with hurricane recovery efforts. In addition, family sick leave limits have been increased for CSU employees who must respond to family illnesses or injuries as a result of Hurricane Katrina. The State Controller's Office also has announced that it has created a payroll deduction to which employees may make donations to California's "Hurricane Katrina Disaster Relief Campaign." ## CSU to independently offer Ed.D degree

Governor Arnold Schwarzenegger has signed legislation (SB 724) that will authorize the CSU to independently offer the Doctor of Education (Ed.D.) degree. This is the first authorization to independently award a doctorate since the system was formed almost half a century ago. The new degree will target K-12 and community college administrative leaders. Previously, under California's Master Plan for Higher Education, the CSU could only offer bachelor's and master's degrees, except for a limited number of doctorates via programs offered jointly with private universities or in partnership with the University of California, such as the program offered by the College of Education. However, workforce demands for doctoral training for administrative leaders for California public elementary and secondary schools and community colleges has far outstripped the state's ability to provide them. The first students are expected to begin their studies for the Ed.D. at selected CSU campuses in **Fall 2007**.
