RESOLUTION ON  
RE-NOMINATING PROFESSOR KATHLEEN E. KAISER  
AS FACULTY TRUSTEE

1 WHEREAS, Professor Kathleen E. Kaiser has been an honored faculty colleague for the last 32  
2 years at California State University, Chico, and has been recognized for her  
3 outstanding teaching and advising, successful grant writing and scholarly  
4 activities, and her remarkable record of service to students and faculty; and

6 WHEREAS, Professor Kaiser has long been dedicated to the principles of shared governance  
7 and academic excellence as reflected in her fifteen years of service to the CSU  
8 Chico Academic Senate and her twelve years of service on the Academic Senate  
9 CSU;and

11 WHEREAS, Professor Kaiser has served in significant systemwide leadership positions and  
12 developed a broad knowledge of California's system of higher education through  
13 her participation on the Executive Committee of the ASCSU, the GE Breadth  
14 Committee, on which she served as chair, the Academic Affairs Committee, on  
15 which she served as vice chair, and the Intersegmental Committee of Academic  
16 Senates where she worked with colleagues from the University of California and  
17 the California Community Colleges in developing intersegmental transfer and  
18 articulation programs in the state; and

20 WHEREAS, Professor Kaiser has been a leader in the state and a champion for course  
21 articulation and transfer between the CSU and all other segments of higher  
22 education in California so that the principle of seamless transfer, as envisioned by  
23 the Master Plan for Higher Education, can be brought to fruition; and

25 WHEREAS, Professor Kaiser has had an extended commitment to service learning and  
26 distance education not only as reflected by her participation on statewide and  
27 international programs, the Technology Task Force, and the Information  
28 Competency Task Force, but also as the director of hundreds of internships at  
29 CSU Chico that place students at sites located throughout California and the  
30 United States as well as a writer, leader, and evaluator of many community based  
31 grants and outreach activities; and

32 WHEREAS, Professor Kaiser has demonstrated time and again that she is a dedicated and  
33 trustworthy colleague who has the ability to articulate and represent the faculty's  
34 perspective in shared governance but recognizes, understands, and values the  
35 necessity to work collegially and constructively with other bodies who have also  
36 been entrusted to carry out the Master Plan for Higher Education; and

38 WHEREAS, Professor Kaiser in her first year of service as Faculty Trustee visited 14  
39 campuses, attended 9 graduations, was the first trustee to accompany the CSU  
40 Maritime Academy's T.S. Golden Bear on Cruise, including presiding at the 'at-  
41 sea' graduation, serves on four BOT committees, is a CPEC alternate, and was  
42 recognized by CSSA as the Outstanding Trustee of the Year in 2004; and

44 WHEREAS, Faculty Trustee Kaiser has been an effective voice for students, faculty, and staff  
45 on the CSU Board of Trustees and has become a respected force on the board that  
46 should be continued for another term; therefore be it

48 RESOLVED: That the Academic Senate of Cal Poly take great pride in re-nominating Professor  
49 Kathleen E. Kaiser for the position of CSU Faculty Trustee.
