ARE NOT ELIGIBLE FOR MEMBERSHIP, WHICH IS LIMITED TO BIOLOGICAL INDIVIDUALS, BUT MAY SUBSCRIBE TO ETHICS AND ANIMALS AT THE RATE OF \$4.00 PER CALENDAR YEAR (PLUS \$2.00 IF AIR MAIL DELIVERY IS REQUIRED). MEMBERS JOINING, OR INSTITUTIONS SUBSCRIBING, AT ANY POINT WITHIN A YEAR WILL RECEIVE THE COMPLETE VOLUME FOR THAT YEAR.
