Preparatory: The meeting was opened at 3:15 p.m.

- I. Minutes: The minutes for the Academic Senate Executive Committee meeting of November 1, 2005 were approved.
- II. Communication(s) and Announcement(s):
  - A. Faculty Referendum to Amend the Constitution of the Faculty: Formula for Determining Academic Senate Representation was passed by the General Faculty.
  - B. Josef Kasperovich (CAED) was elected to the Academic Senate as the representative for part-time academic employees.
- III. Reports:
  - A. Academic Senate Chair: None.
  - B. President's Office: (Howard-Greene) the Governor's budget is due to come out within the next couple of weeks and will include a report on the Governor's buy-out of student fees.
  - C. Provost Office: (Detweiler) The topic of the Academic Bill of Rights is being discussed among certain faculty members, specifically regarding academic freedom and responsibilities. It was urged that the University Council on Citizenship discuss this issue. The Administration is aware of the issue and encourages healthy discussions without promoting a particular policy.
  - D. Statewide Senators: (Hood) The Governor's buy-out of student fees is a permanent adjustment to the CSU base budget. The Administration will augment the CSU budget by approximately \$54.4 million in lieu of a student fee increase. There is currently discussion in the CSU to adopt the same position as the UC in regards to their policy of not accepting articulation of courses with intelligent design and creationism discussions as part of the course.

**RESOLUTION ON  
TEXTBOOK PRICING**

1 WHEREAS, The Associated Students, Inc of Cal Poly (ASI) has expressed its concern  
2 regarding the rapid rise in textbook pricing by recently approving a resolution  
3 addressing this matter; and

5 WHEREAS, The Academic Senate of Cal Poly has supported the principles set forth in the ASI  
6 resolution; and

8 WHEREAS, The complexity of textbook pricing necessitates a comprehensive study of the  
9 issues and a search for solutions; and

11 WHEREAS, The Academic Senate of Cal Poly recognizes that the high cost of certain  
12 textbooks and coursepacks can adversely affect the affordability of higher  
13 education for its students; and

15 WHEREAS, The Academic Senate of Cal Poly and the University must protect the academic  
16 freedom of faculty in assigning textbooks and other course materials while  
17 recognizing the negative impact high textbook prices has on its students; therefore  
18 be it

20 RESOLVED: That the Academic Senate of Cal Poly encourage its faculty to consider the  
21 following steps in managing textbook costs to students:

- 23 1. Review prices for different textbooks and textbook packages before  
24 ordering;
- 25 2. Require new editions of continuing titles only when important changes  
26 have occurred in content;
- 27 3. Submit textbook requests as soon as possible to ensure the availability of  
28 textbooks through campus and local bookstores;
- 29 4. Use coursepacks, e-reserves, and other cost mitigating formats whenever  
30 pedagogically sound and feasible;

31                   5. Communicate clearly with publisher representatives regarding textbook  
32                   pricing and options available;

36   RESOLVED: That the Academic Senate of Cal Poly reaffirm the fundamental right and  
37                   responsibility of faculty to maintain intellectual content and teaching effectiveness  
38                   as prime considerations when selecting traditional textbooks, alternative formats,  
39                   and ancillary items of instruction; and be it further
