- I. Minutes: the minutes of April 17 were approved as presented.
- II. Communications and Announcements: Giberti announced President Baker's attendance at today's meeting.
- III. Regular Reports:
 - A. Academic Senate Chair: Giberti reported on his presentation at the Access to Excellence Summit on excellence in student learning.
 - B. President's Office: President Baker announced that he would attend the May 29 meeting to report on the May budget revise and its implications to Cal Poly.
 - C. Provost's Office: Durgin reported that Cal Poly has met its enrollment target for next year. The 2007-2008 pool includes a record number of National Merit and Hispanic Scholar applicants.
