## Campus Administrative Policies Update

Cal Poly is undertaking a comprehensive review of its administrative policies that will result in a new collection of "Campus Administrative Policies" (CAP), published on the Web and in hard copy format. CAP will take the place of the pre-existing Campus Administrative Manual (CAM).

## **Administration Building Second Floor Offices Move for the Summer**

The second floor of the Administration building will undergo a major abatement and re-roofing project beginning in June.
