California General Elections are Tuesday, Nov. 7

The California State University System and Cal Poly remind the campus community that California's general elections are **Tuesday, Nov. 7**. San Luis Obispo County polls open at **7 a.m.** and close at **8 p.m.**, according to County Clerk-Recorder Julie Rodewald.

Cal Poly and Prop 1-D

The upcoming **Nov. 7** ballot will include Proposition 1-D, a measure that allows the state to sell general obligation bonds for K-12 schools and higher education. Proposition 1-D funds will provide Cal Poly with \$16.7 million over two years for the following projects:

1. **Planning and Design for a New Center for Science & Math**
The university's engineering, architecture, and science and mathematics curricula depend heavily on the ability to provide instruction in science and mathematics. Technology used in classrooms and laboratories today has advanced greatly since the existing science building was built in 1962 – when there were only 5,000 students on campus. To provide students with the learn-by-doing competitive edge, Cal Poly requires access to up-to-date equipment and processes, so that students can hit the ground running in the workplace. Proposition 1-D funds will provide for the planning and design of the proposed 145,000 square-foot, multi-story Science Center that will house chemistry, physics and soils science laboratories; research facilities; classrooms; and the mechanical and electrical infrastructure needed to create the high-quality learning environment Cal Poly students deserve.
2. **Replacement of Anderson Pool**
Prop. 1-D funds will provide for the replacement of the 40-year-old Anderson pool with a modern pool that meets newer standards for academic use. Improvements include installation of turbulence-reducing gutters and an energy-efficient heating system. The pool supports the university's kinesiology program, athletic team events, water safety, lifeguard training, swimming and aquatic exercise.
3. **Minor Capital Projects Classroom Upgrades, ADA, Library Renovations and more**
Prop. 1-D funds will provide for upgrading aging classrooms, labs and restrooms, as well as Americans with Disability Act compliance, Kennedy Library renovations and multimedia technology installations.
4. **Equipment for the Construction Management Building**
Proposition 1-D funds will provide audio visual, communications and maintenance equipment and furniture needed to outfit the brand new building that is currently under construction.

Winter Fee Waiver dates - revised since last Cal Poly Report

Oct. 25 – CPReg scheduled registration period began (see "Priority and Graduate Students" category in Plan A Student Schedule (PASS) via the portal).

Nov. 16 – Last day to pay fees to avoid \$25 late fee.

Nov. 30 – Last day to submit fee waiver form to Human Resources, Administration, Room 110. (Note: Effective with the Winter 2007 quarter, fee waiver forms will be required no later than two weeks after registration to accommodate timely coding into the new student information system.)

Dec. 1 – Last day to submit CSU admission application (undecided/non-matriculated status only).

Eligible employees who transfer their fee waiver benefit to their spouse, dependent or registered domestic partner must complete a new Dependent Fee Waiver Designation form (HR 133C) by **Dec. 1** for the winter quarter. New procedure to access campus wireless network
