FEDERAL WORK-STUDY UPDATE

Due to a significant drop in Federal funding in the Federal Work-Study (FWS) Program, there are a limited number of students with FWS funds. We regret that there are no additional FWS funds available for this academic year, nor will increases in existing Federal Work-Study awards be possible.

FWS was awarded to applicants with a high need who filed a FAFSA application before the March 2 deadline. Encourage students to complete the 2009/10 FAFSA at <http://www.fafsa.ed.gov> . Since we were unable to grant additional requests for Federal Work-Study in 2008/09, students on the FWS waiting list will be given priority for FWS in 2009/10 providing they meet the need requirements and file their FAFSA before the March 2 deadline.
