The Animal Alliance of the Rocky Mountains is a coalition formed for the sole purpose of publishing a joint newsletter. Several national groups such as the Fund for Animals, International Fund for Animal Welfare, Farm Animal Reform Movement, and Animal Legal Protection Association have representatives in the Rocky Mountain area. These representatives along with members of local groups determined that to foster cooperation and communication among leaders, members and interested persons, a combined newsletter would be effective and helpful. AARM hopes to encourage the participation of other local and national groups in the newsletter, and welcomes the recent addition of People for the Ethical Treatment of Animals (PETA) to AARM. Each issue contains a feature article, legislative update (local and national issues), a description of another animal group, a calendar of local and national events, "Action Alerts" (issues requiring letters or other action, such as contests offering fur coats, etc.), and a page from each participating group outlining their policies and activities. AARM has no paid staff. All subscription fees go toward paying printing and postage costs. The AARM newsletter is published every other month. Annual subscription is \$8.00. The goal of the organization is to eliminate the exploitation of animals in all forms. Issues that are of particular concern include, but are not limited to, the plight of companion animals and the pet overpopulation problem, the use of animals in laboratories for research and product safety testing, animals raised for human consumption, animals exploited for entertainment, and the protection of wildlife, including marine mammals. Scientists' Group for Reform of Animal Experimentation

The Scientists' Group for Reform of Animal Experimentation (SGRAE) is an organization of scientists concerned with ethical problems of animal experimentation, and interested in promoting humane approaches to biological research, testing, and education.

SGRAE offers expert advice and testimony to governmental, scientific, and humane bodies. It cooperates with humane, scientific, and other professional groups to achieve common goals.

SGRAE opposes the use of pound animals for experimentation, on both scientific and humane grounds.

SGRAE opposes the use of muscle relaxants (paralytic agents) for experimental animals, except under adequate general anesthesia.

SGRAE opposes invasive or distressing experiments on vertebrate animals by high school or college students.

SGRAE favors accountability by scientists who use animals.

SGRAE favors the development and use of alternatives that replace the use of animals, reduce the numbers used, or refine the procedures so that there is less stress.

SGRAE has put out position papers on pound seizure and on the use of animals in schools. Position papers on alternatives, on exercise and environmental enrichment and on the use of muscle relaxants, will be ready in the near future.

In order that SGRAE may speak as a group of scientists, voting membership is limited to physicians, dentists, veterinarians, and research scientists in fields in which experimental animals are used. Graduate students in these fields may become non-voting members. Annual membership dues are \$5.00. Although membership is limited, the consideration and financial support of all those concerned with the welfare of experimental animals is welcome.
