  - C. **Curriculum proposal for Ethnic Studies:** The Curriculum Committee approved all the entries on the Ethnic Studies proposal sheet. Three additional proposals will be brought to the Senate floor on November 30: P.E. & Kinesiology, Crop Science, and NRM.
  - D. **Resolution Establishing an Ad Hoc Committee on Governance:** Discussion was held as to whether a faculty committee on governance should be formed concurrent with the Charter Campus Task Force subcommittee on governance since there are only two faculty members on the Task Force subcommittee. The following motion was M/S/P (Bertozzi/Gooden):

That the Academic Senate Executive Committee take the position that at least half of the membership of any governance committee appointed by the Charter Oversight Committee to examine charter issues be constituted of faculty members.

Fetzer requested that a second Resolved clause be added that would include tenure-track faculty as eligible for membership to a governance committee. It was suggested that a memo go to all faculty with a copy of the proposed (edited) resolution. Further discussion on this matter was postponed until the next Executive Committee meeting.

One additional meeting of the Executive Committee will be scheduled during final's week in order to determine what matters should come before the Academic Senate during the remainder of the 1993-1994 academic year.
