Professor Chris Carr named associate dean

Business Law Professor Chris Carr has been appointed associate dean in the Orfalea College of Business. Carr joined the OCOB in 1995 as a part-time lecturer in business law. He subsequently accepted a full-time appointment, advancing to associate professor in 1998 and full professor in 2004. A 1987 graduate of the University of Nebraska at Lincoln, Carr went on to earn his Juris Doctor degree with honors from Santa Clara University School of Law in 1990. In 1998 he earned an M.A. in political science from UCLA. Carr has practiced law as an attorney with The Jencks Law Group in Arroyo Grande and Sinsheimer, Schiebelhut & Baggett in San Luis Obispo. OCOB Dean David Christy said Carr is the right person to provide leadership in graduate programs and a variety of new initiatives in research and program improvement.

Clif Bar founder to give lecture Nov. 29

Successful entrepreneur and author Gary Erickson, the founder of Clif Bar Inc., will discuss business and ethics **Monday, Nov. 29**, in Philips Hall in the Performing Arts Center. The presentation will start at **7:15 p.m.** and is open to the public. Erickson is heralded nationally as a visionary entrepreneur. "He believes there is more to business than the bottom line, and his company's bottom line is doing very well, in part because of that strong belief," said Orfalea College of Business Dean Christy. Clif Bar Inc. has been named four times to Inc. magazine's annual list of fastest-growing companies in the United States. What started as a small bakery is today one of the leading makers of all-natural energy and nutrition foods.

Steps remain for state budget approval

Though the CSU Board of Trustees has approved the 2005-06 Support Budget request as submitted by the Chancellor, several steps are pending in the state budget development process:

- December - Department of Finance (DOF) submits budget recommendations to the Governor
- January 2005 - Governor submits his budget to the Legislature
- February 2005 - Legislative Analyst Office (LAO) publishes the Legislative Analyst's report on the Governor's budget
- Spring 2005 - Legislature considers the Governor's budget
- May 2005 - May Revise will be based on updated information about state revenue and expenses
- June 2005 - Legislature acts on the budget
- July 2005 - Governor signs the 2005-06 budget

The current estimate of the state's budget gap for 2005-06 is approximately \$6 billion. "We will continue to monitor the budget as it develops and report on the progress," said Larry Kelley, vice president for administration and finance.
