#### BACKGROUND

When faculty FTEF allocations are made to each school, the dean is provided the authority for intra school distribution. Historically, the Office of the President has not accorded even this minor recognition to the Academic Senate which by any interpretation of collegiality is a partner in the shared decision making process.

#### RESOLUTION ON DISTRIBUTION OF ASSIGNED TIME

(This is a resolution of the Executive Committee)

Whereas, For Spring 1986, President Baker has asked the Provost to consider a 0.4 FTEF increase in assigned time for the Academic Senate; and

Whereas, For Summer 1986 a second reading Academic Senate resolution requests 0.25 FTEF for the Senate chair position, and

Whereas, For Fall, Winter and Spring 1986-1987, a second reading Academic Senate resolution requests 2.0 FTEF total Senate assigned time;

Whereas, Historically, the distribution of FTEF within the Academic Senate has been determined by administration rather than by the Academic Senate Executive Committee; therefore

Resolved. That the Academic Senate Executive Committee urge President Baker to accord to the Academic Senate a working relationship consistent with partnership status; therefore

Resolved. That pending implementation of the preceding resolved clause, the Academic Senate Executive Committee recommends to President Baker, the following division of Senate assigned time for Spring 1986 and for fiscal year 1986-1987:

## RESOLUTION ON TIME FRAME FOR SUBMISSION OF SENIOR PROJECT GRADES

WHEREAS, Executive Order 268 "Grading Symbols," dated September 1, 1977 states:

The Senior Project symbol shall be used in connection with thesis, project, and similar courses where assigned work frequently extends beyond a single academic term and may include enrollment in more than one term; and

- WHEREAS, The Senior Project symbol is replaced with an appropriate final grade within one year of its assignment except for Master's thesis enrollment (in which case the time limit shall be established by the appropriate campus authority); and
- WHEREAS, At California Polytechnic State University, there is no policy whereby a Senior Project is converted to a grade of "F" after a designated time period has elapsed and the work is not completed; therefore, be it
- RESOLVED: That an "SP" symbol, assigned for undergraduate project work, be converted to a grade of "F" if the work is not completed within one calendar year immediately following the term during which it was assigned; and be it further
- RESOLVED: That a similar policy with a two-year limitation be assigned for Master's thesis work.

#### Background:

Since 1981, the Education Department has offered a course entitled "Maintaining Teacher Effectiveness" to help Cal Poly instructors improve their communication skills and, hence, their effectiveness in the classroom. There is considerable documentation attesting to the value of this program as an instrument to improving teaching effectiveness. This course has been dropped from the 1986-1988 catalog due to lack of funding. This leaves a major void in the discipline of teacher effectiveness training for Cal Poly's faculty. The Instruction Committee of the Academic Senate herewith submits the following resolution:

- WHEREAS, California Polytechnic State University is a noted undergraduate teaching institution; and
- WHEREAS, effective teaching is essential to maintaining a quality undergraduate program; and
- WHEREAS, Expertise in a given discipline alone does not ensure effective communication of this knowledge to others; and
- WHEREAS, ED 581 (now ED 412) which has proven to be an effective program assisting faculty in this important aspect of professional growth and development has been dropped from the 1986-1988 catalog due to lack of funding; and
- WHEREAS, Cancellation of the Education Department's offering amounts to a cancellation of the Cal Poly Teacher Effectiveness Program; and

- WHEREAS, This absence of a program for faculty development is contrary to the best interests of the university in maintaining a quality undergraduate program; and
- WHEREAS, The Ad Hoc Committee on Use of Lottery Funds has recommended the use of these monies for teaching methodology improvement; therefore, be it
- RESOLVED: That California Polytechnic State University establish a program to (1) assist teachers in developing their instructional competence, and (2) encourage experimentation in teacher effectiveness including programs involving interdisciplinary projects; and be it further
- RESOLVED: That California Polytechnic State University create and maintain an organized program, to include a course such as ED 412 "Maintaining Teacher Effectiveness" to accomplish these goals and support such a program on an ongoing basis.

Subject: Faculty Position Summary - Assigned Time Detail

This is in response to your request of November 8, 1985 regarding assigned time utilization for 1985/86. Since your request goes beyond assigned time, I am providing a summary of the 906.3 positions contained in the Instructional Faculty cost center of the 1985/86 General Fund Support Budget.

The quarterly detail of the allocations marked with an asterisk or a double asterisk is outlined on the attached table. Assigned time is allocated from among the 11.5 positions marked with the double asterisk although as indicated on the detail, a number of the positions have gone to schools to satisfy unanticipated high demand coursework. The balance remaining from this 11.5 position total is 1.381 FTE positions. Obviously with two quarters of the Academic Year remaining, this is an extremely small reserve from which to

service any health emergencies or high demand classes.

In addition, the deans have been delegated the authority to allocate assigned time to faculty within their school from the school faculty position allocation.

Subject: Use of Released Time for the Chair of the Academic Senate

The Chair of the Academic Senate is responsible for setting the agenda for the Executive Committee meetings and presiding over the Executive Committee meetings and the meetings of the full Academic Senate. The Chair acts as principal correspondent for the Senate. He transmits the work of the Senate to the President and explains the Senate's activities orally to the President. He also communicates with the Statewide Academic Senate, the Provost, and others on behalf of the Academic Senate. In addition, the Chair acts as an informal liaison with the faculty and administration on behalf of Senate.

In addition, he coordinates and oversees the Standing and Ad Hoc committees of the Senate by guiding work among them and forwarding their work to the Executive Committee and the full Senate. The Chair also represents the Senate in a variety of circumstances before the public and other organs of the University and the CSU system (e.g., speaking at commencement and fall conference, participating in meetings of some system-wide entities, being prepared to deal with the campus and local press).

During the past year, the Academic Senate has been very active. It has developed and recommended policy on: administrative structure for general education and breadth; faculty/staff club; UCSB library shuttle; endorsement of the document on responsibilities of Academic Senates within the collective bargaining context; report on the effect of the collective bargaining agreement on review, grievance, and continued existence of the PRC; curriculum, EMSA's; review committee of the emergency response plan; CAM 700; university reorganization; commencement; and the Uri Treisman visit. Naturally, the chairman was significantly involved with effecting these developments.

Another significant portion of the chairman's time is taken up by discussions with faculty who have questions or concerns which the Senate might be able to address. All in all, the amount of time required for these various responsibilities exceeds the available .6 position.
