RESOLUTION ON CONCENTRATION DEFINITION

- 1 WHEREAS, A concentration is intended to be a coherent and specialized course of study within a
2 student's major degree program, which presupposes knowledge of the major
3 discipline; and
- 4 WHEREAS, A concentration is a carefully chosen and formally recognized course of study with
5 requirements stated in the catalog; and
- 6 WHEREAS, Faculty have a commitment to deliver approved curriculum; and
- 7 WHEREAS, Concentrations, including interdisciplinary concentrations, are not baccalaureate
8 programs; and
- 9 WHEREAS, Concentrations are noted on the student's transcript, but not shown on the diploma;
10 and
- 11 WHEREAS, Faculty have the option to include concentrations in the baccalaureate programs they
12 develop; and
- 13 WHEREAS, CSU Executive Order 602 delegates authority to campus presidents to approve
14 options, concentrations, special emphases and minors
15 (<http://www.calstate.edu/eo/EO-602.pdf>); and
- 16 WHEREAS, The only curricular constraint mandated by Executive Order 602 is that in order to be
17 approved by campus presidents, concentrations must be "in the same discipline
18 division as the approved degree major program" otherwise they require approval by
19 the Chancellor; be it therefore
- 20 RESOLVED, That CAM 411.A.1(c) on concentrations be revised as follows:
- 21 • A concentration is a block of at least five designated ~~major~~ courses (E.O. 283)
22 from one or more lists of designated courses or course areas.
 - 23 • No single course should appear in every concentration: such courses should be
24 included in the major.

- 25 • The courses for a concentration shall appear in the major course column.
26 • ~~At least 50% of the units in a concentration shall be in the same courses or course~~
27 ~~areas for all students taking that concentration~~
28 • **The number of concentration units shall not exceed 50% of the total major**
29 **units.**

30 And further be it

31 RESOLVED, That the above CAM concentration criteria be effective for all new concentration
32 proposals or concentration revision proposals beginning with the 2013-15 catalog
33 cycle; and be it further

34 RESOLVED, That when advising individual students, reasonable attempts to follow the approved
35 curriculum should be made before substitutions are considered.
