Voters approve Prop. 47

California voters said yes to Proposition 47 by a solid margin Nov. 5, approving a \$13 billion school building bond that will give Cal Poly more than \$37 million over the next two years.

Statewide, Proposition 47 received 57.5 percent of the vote. In San Luis Obispo County, where the bond would fund classroom building projects at Cuesta College and K-12 schools in addition to Cal Poly, the measure passed with 52 percent of the vote.

Sexual harassment focus of Nov. 20 training

The Campus Relations office is providing two training sessions in sexual harassment prevention on Nov. 20. The training is designed to meet the campus policy that requires new employees to complete two hours of sexual harassment training before the end of their second quarter of employment.

Two sessions are planned: The first, for staff members and management personnel, will be 9-11 a.m. The second is for faculty members and department heads and chairs and is set for 1-3 p.m. Both sessions will be in UU 204.

Although each session is designated for certain classifications, anyone is welcome to attend either session.

The morning session will give examples specific to staff members, and the afternoon session will be directed primarily toward the faculty. Information will be given about the campus policy on sexual harassment, the employee's responsibility, and how to handle difficult situations.

Local charities need help

Local charitable organizations are experiencing severely tightened budgets this year because of the economy and state budget cuts and are asking for extra help from Cal Poly employees and others countywide.

Janna Nichols, executive director of the United Way of San Luis Obispo County, said local charities are facing reductions in funding just at a time when the need for social services is increasing.

Cal Poly's 2002 California State Employees Charitable Campaign and the United Way campaign for ASI and Foundation employees enable Cal Poly employees to give through payroll deduction, cash or check to any tax-exempt non-profit organization, wherever it might be. The annual campaigns, now beginning, run through Nov. 22.

United Way of San Luis Obispo County manages the State Campaign in the county, and donations not specified for another organization go to the local United Way's Community Fund. Those gifts are distributed among more than 50 programs that aid county residents in need.

D. Edward Glassco, 61

Mathematics Professor Emeritus Ed Glassco – the department's resident Macintosh computer expert – died Nov. 1 at his home in Morro Bay.

Glassco began teaching at Cal Poly in 1968. He retired in 2001; however, he was still providing technology support to the department and teaching under the Faculty Early Retirement Program. He was instrumental in developing and maintaining the mathematics studio labs, and in providing computer expertise and assistance to the faculty and staff and students. □
