Utah arts administrator to head Cal Poly Arts

The former executive director of Capitol Arts Alliance of Logan, Utah, has been selected director of Cal Poly Arts.

Ralph Hoskins succeeds Ron Regier, who left the post to become the first managing director of the Performing Arts Center.

Hoskins, who took up his new duties Oct. 2, is responsible for managing and marketing public arts events at the university. He is also responsible for fund-raising efforts that support campus arts activities.

Hoskins was executive director of Capitol Arts Alliance, a regional arts council, for three years. He brought more than 100 performances and exhibits annually to its 1,100-seat theater and art gallery and oversaw box office operations as well as all aspects of fund raising, marketing, maintenance and operations.

HIV/AIDS awareness activities planned

October is HIV/AIDS Awareness month, and Cal Poly has scheduled a variety of activities designed to increase understanding and awareness of various aspects of the condition and illness.

Beginning Saturday, Oct. 14, through Friday, Oct. 20, El Corral Bookstore will display works on HIV and AIDS. The Mustang sculpture in the area between the Administration Building and the UU will be draped to symbolize the effect AIDS has on the arts. Other events include:

- ♦ Oct. 14: Students in the residence halls will participate in an AIDS Walk

to collect food and clothing for the AIDS Support Network.

- ♦ Oct. 16 and 17: HIV/AIDS information will be available at the Collegiate Health and Fitness Event on Dexter Lawn.
- ♦ Oct. 19: A presentation and discussion on "Hispanics and HIV/AIDS" will be held from 1 to 2 pm in the Multicultural Center.
- ♦ Oct. 24: "Skip-A-Meal" will be sponsored by Residential Life and Education. Students will go without dinner and donate the cost of the dinner to the AIDS Support Network.

Homecoming '95 set for Oct. 19-22

Cal Poly is planning four days of activities to celebrate Homecoming '95, from Thursday through Sunday, Oct. 19 to 22.

The alumni classes of 1945 and 1970 will be honored at this year's Homecoming, which begins with opening activities at 11 am Thursday, Oct. 19, in the UU Plaza.

The theme this year, The Best in the West, celebrates the fact that Cal Poly was selected by U. S. News and World Report for the third year as the top public university in its category. The theme also recognizes the Mustang football team's standing as defending champions of the American West Conference.

Aeronautical engineering alumnus and astronaut Robert L. "Hoot" Gibson will be the grand marshal at the Homecoming Parade, set to begin at 10 am Saturday, Oct. 21, in downtown San Luis Obispo. Gibson docked the space shuttle Atlantis to the Russian space station Mir in June, during his fifth journey into space.

Also on Saturday, the Alumni Tailgate Barbecue and Wine Tasting is planned for 11:30 am in Poly Grove and on the lawn by the Business Building. Tasters will have an opportunity to sample such Central Coast favorites as Meridian, Edna Valley, Mastantuono and Byron and receive a souvenir glass.

Barbecued tri-tips will be served before the 2 pm football game in Mustang Stadium, where Cal Poly will play Sacramento State.

Also planned as part of Homecoming activities is the Honored Alumni and Reunion Banquet, to be held Friday night at the Forum in downtown San Luis Obispo. Gibson will be the

African-influenced a capella group to sing

Their message is peace and social justice for all. Their music – traditional, contemporary and original – embodies the rhythmic and historical influences of Africa.

They are Street Sounds, an Oakland-based group, and they will perform at 8 pm Friday, Oct. 27, in the Theatre.

The performance is the third a capella vocal ensemble to be presented as part of Cal Poly Arts' 1995-96 season.

Founder and artistic director Louise Robinson will be joined by vocalists Michelle Jacques, Steven Thomas, Bryan S. Dyer and Rhonda Crane in performing a variety of a capella vocal music combining African chants, blues, jazz, civil and human rights songs, rap, rhythm and blues, doo-wop, traditional gospel, calypso and salsa.

Since its inception six years ago, Street Sounds has evolved from playing one-song engagements to appearing with renowned Bay Area groups

and vocal artists such as folk icon Pete Seeger.

Seeger calls the group "both inspiring and spirited; a sound the world can embrace."

Street Sounds will also be serving as mentors to a group of students from South Central Los Angeles who will be visiting San Luis Obispo as part of Project Link. (The program, formerly called Koger Kamp, brings Los Angeles-area youths to the Central Coast to experience life outside the city.)

During their visit the students will meet with members of Street Sounds to discuss social issues and hear what it is like to be a performing artist.

They will also spend time with representatives from Cal Poly Arts to learn about the business of "presenting."

Concertgoers will see the students helping out in the Cal Poly Theatre lobby the night of the performance.

Tickets for Street Sounds are \$14 and \$12 for the public and \$12 and \$10 for students and senior citizens. For reservations, call the Anytime Artsline at ext. 1421.

CalPERS will be testing two new financial planning seminars throughout the state at no cost to PERS members during 1996.

The first, Planning Your Retirement, is designed for members who are 5 to 10 years away from retirement. This two-day seminar will run from 8:30 am to 4 pm and will include information on CalPERS benefits and options, deferred compensation, investment concepts, estate planning, Social Security, setting financial goals, lifestyle changes, tax planning and insurance options.

The second seminar, Achieving Financial Independence, is designed for members who are 10 or more years away from retirement. This one-day seminar, from 8:30 am to 4:30 pm, will include information on CalPERS benefits and options, deferred compensation, cash management, tax planning, estate planning, investment concepts, setting financial goals and insurance options.

A number of seminars are scheduled for January through June. Only one, Planning Your Retirement, will be held in San Luis Obispo, and that will be on April 24 and 25.

All CalPERS members are eligible to participate. Spouses may also attend if attendance is requested at the time members register. Attendance is limited to 50 participants per seminar, including spouses. Registration is by registration form only. 

Pastry chef Harman runner-up in contest

Women's Studies seminar scheduled for Oct. 23

Music professor Alyson McLamore will explore women and music in 18th-century London as the first fall quarter program of the Women's Studies Lunch-Time Seminar series.

McLamore will discuss "Led By a Woman! Entrepreneurs of the Concert Room in 18th-Century London" at noon Monday, Oct. 23, in the Staff Dining Room.

The talk is based on McLamore's research on the concert careers of Ann Ford (1737-1824) and those of other female musical entrepreneurs.

Ford overcame much parental opposition to perform. Her father at one point had her arrested and confined to prevent her from playing in public.

Ford was not the first 18th-century woman to mount a public concert series, nor was she the last. McLamore will address such questions as:

♪ What were the characteristics of 18th-century concert life, and how do those differ from concerts today?

♪ Why would an 18th-century father oppose a daughter's public music career?

♪ What was society's response to women performing leadership roles in concert management?

♪ What role did the English class system play in determining the success or failure of musical enterprises.

PERS to hold long-term care seminars

A representative of the Public Employees' Retirement System (PERS) will hold two workshops on the Long-Term Care Program, a new benefit for PERS employees and retirees.

Long-term care – normally not covered by health care policies – helps pay for care when assistance with daily living, such as dressing, bathing, or eating is needed because of illness, injury or old age.

Care can be provided at home, in assisted-living facilities, in an adult day-care center, and in nursing homes.

The benefit is offered to PERS members, their spouses, parents and parents-in-law at a cost 30 percent lower than most other plans.

Two one-hour workshops are scheduled on Tuesday, Oct. 31, from 9:30 am to 10:30 am and again from 11 am to noon, in UU 220.


