- II. Communication(s) and Announcement(s): None.
- III. Reports:
 - A. Academic Senate Chair: (Fernflores) The Chair has been told by statewide senator Forooohar that the CSU is not taking any further action on the issue of for-profit sites, especially Course Hero. A meeting was held last Friday with California State Senator, Sam Blakeslee, to discuss his proposal for a public policy center at Cal Poly. It was a very productive meeting and the proposal could come to the Academic Senate as early as fall quarter 2012.
 - B. President's Office: (Kinsley) The President's focus groups will continue to meet until mid-May. The President has much appreciation for everyone that has attended. Valuable input has been received. Details on Faculty Trustee Bernadette Cheyne's visit to Cal Poly on May 29 and 30 will be available soon. Kinsley was asked whether any information was available on the 'quarters versus semesters' issue. Kinsley replied there was nothing to report at this time. If a decision to move to semesters is decided, faculty, staff, and students will all need to be involved.
 - C. Provost: (Enz Finken) None.
 - D. Statewide Senate: (Forooohar) More than 20 resolutions were approved at the last plenary session, five of them are very important for the future of academic freedom and shared governance. . The resolution amending the *Constitution of the Academic Senate of the CSU* to include a statement on academic freedom will return to campuses for a vote before going to the Chancellor's Office and Board of Trustees. The joint statement on academic freedom signed by Presidents Armstrong, Hellenbrand and Welty was also endorsed by the ASCSU. Three other resolutions were approved to established clear procedures for implementation of shared governance.
 - E. At the statewide meeting, The Vice President for Finance reported on various ideas for dealing with potential budget cuts. One idea was to create a charter campus (or two); however, the idea is opposed by Chancellor Reed.
 - F. CFA Campus President: (Thorncroft) None.
 - F. ASI Representative: (Tabrizi) Students have been discussing and are concerned about the possible CSU faculty strike and how it will affect their education. All options are being discussed by the statewide student organization, CSSA, for dealing with the budget crisis. An ASI resolution will be forwarded to the Senate on "The Mustang

Way.” This is a new project anticipated to infuse students with a sense of pride and responsibility. ASI would like to make it a campus-wide statement.
