

## Memorial scholarship to honor Bob Mott

A scholarship endowment is being established in memory of Dr. Robert A. Mott, former Physical Education Department head, who died on April 15.

The Physical Education and Recreation Administration Department in conjunction with the Mott family has established the endowment fund to recognize Dr. Mott's contributions to Cal Poly and the physical education profession. Earnings from the endowment will provide financial assistance to qualified students majoring in physical education with a concentration in teaching.

According to Dwayne Head, PE/RA Department head, "Dr. Mott was a pioneer physical educator whose goal was to have all California youth involved in quality physical education and athletic programs. This scholarship endowment will be used to encourage deserving students to enter the teaching and coaching professions, thereby continuing with the work Bob began over 40 years ago."

## Key propositions will be voted on Tuesday

Tuesday (June 5) is Primary Election Day in California. Over the past few weeks we have discussed the importance of Prop. 111 and 121 to Cal Poly.

We have discussed the higher education implications of Prop. 111, but have not mentioned the transportation needs that would be addressed. For example, the following San Luis Obispo County highway projects would be delayed indefinitely if Prop. 111 fails:

- ✓Route 1 — Improve curve near Nipomo at Callender Road;
- ✓Route 41 — Construct 2-lane highway on new alignment in Atascadero;
- ✓Route 46 — Construct passing lanes east of Paso Robles from Airport Road to the east junction of Highways 41/46;
- ✓Highway 101 — Upgrade interchange in Nipomo at Tefft Street;
- ✓Highway 101 — Upgrade interchange in Arroyo Grande at Oak Park Road; and
- ✓Highway 101 — Upgrade interchange, add lane on freeway in Pismo Beach at 4th Street.

A number of other highway projects involving Routes 41, 46 and 101 will be eligible for additional funds if Prop. 111 passes.

The other measure on Tuesday's ballot is Prop. 121, a bond measure to finance construction projects at all three segments of California public higher education.

Four Cal Poly projects worth nearly \$8 million are on the ballot. They are \$7.27 million in construction money for the Physical Education/Recreational Sports facility; \$270,000 in planning funds for the new Performing Arts Center; \$167,000 in planning money for Dairy Science II; and \$82,000 in planning money for the Poultry Science Unit.



### Bechtel engineer to give talk today

### Pacific Rim series final talk scheduled

Michio Katsumata, Los Angeles bureau chief for Nihon Keizai Shimbun, Japan's largest financial daily, will be the final speaker in a year-long look at the Pacific Basin.

The Japanese journalist will examine "Pacific Rim — A Journalist's View" on Friday, June 1, at 11 am in Fisher Science 287.

His talk is part of the series, "California and the Pacific Rim: Challenges and Opportunities." The interdisciplinary lecture program was established by three departments in the School of Liberal Arts — Political Science, Journalism, and Social Sciences. The series is underwritten by state lottery funds.

Katsumata has been Los Angeles bureau chief since 1987, and he covers economic and industrial developments on the West Coast and in Mexico. He specializes in reporting such issues as emerging labor conflicts in U.S.-Japanese management ventures, the activities of Japanese subsidiaries on the West Coast, and the impact of those activities on American society.

## Officers, members elected by board

Officers and new members were elected during a recent meeting of the Board of Directors of the Foundation.

Re-elected to one-year terms as officers were Howard West as chairman of the board; Dr. Hazel J. Scott, vice chairman of the board; and Dr. Lark P. Carter, secretary-treasurer. West is executive assistant to the President, Scott is vice president for student affairs, and Carter is dean of agriculture.

In other action during the meeting, West was re-elected to a three-year term on the board and both Dr. Peter Y. Lee and Frank T. Lebens were elected to the board for three-year terms.

Lee is dean of engineering, and Lebens is the associate vice president for academic resources.

They fill positions formerly held by retiring board member Dr. Robert A. Lucas, associate vice president for graduate studies, research, and faculty development, and Dr. Malcolm W. Wilson, who retired as the university's vice president for academic affairs.

Announced during the meeting was the reappointment of George H. Soares to a one-year term as the public member on the Board of Directors. Soares is an alumnus of Cal Poly and an attorney with offices in Hanford and Sacramento.

The board provides policy direction for operations of the Cal Poly Foundation, a separate legal entity that operates as an integral part of the university under procedures established by the Trustees of The California State University.

## Search committee
