

PROFS upgrade scheduled May 20

On Monday, May 20, the PROFS electronic mail system on OASIS will be upgraded to PROFS Extended Mail. This upgrade will allow all PROFS users to send and receive all types of electronic mail, such as UNIX, BITNET and Internet mail, directly from PROFS. With PROFS Extended Mail, all incoming mail can be read, responded to, and stored using standard PROFS function keys. PROFS notes can also be sent to other computers on campus or to other BITNET or Internet sites. In addition, a single distribution list can be created for users on a wide variety of computer systems.

PROFS users will notice some minor differences in PROFS, such as the format of notes, and what happens when an invalid nickname or address is entered. A flyer providing detailed instructions for sending mail to other PROFS users on campus will be mailed to all faculty and staff prior to the upgrade. Additional documentation on using PROFS Extended Mail to communicate with other mail systems will also be available at that time.

Representatives of the five available health insurance carriers will be attending, including CIGNA (replaces EQUICOR), Health Net, Health Plan of America (new), Lifeguard, and PERS-CARE. Employees and their spouses are encouraged to attend this informal question and answer session. Appointments are not necessary. A representative from the Personnel Office will also be available to process health insurance open enrollment forms. Due to limited space, other benefits representatives, such as from credit unions and mortgage institutions, will not be attending.

After lunch, Gene Spafford of Purdue University will discuss checking for common network

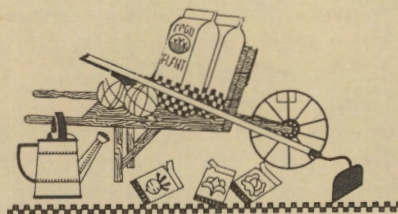
security problems, preparing for a break-in, and cleaning up afterward.

Spotlight on civil rights May 13-17

Cal Poly's second annual Civil Rights Awareness Week has been scheduled for the week of May 13 through 17.

During the five-day program, 31 seminars and 37 speakers will present information on Affirmative Action, rights of the developmentally disabled, the future of higher education, and issues of race and gender.

Most of the sessions will take place in the UU. The event is sponsored by the Civil Rights Awareness Committee, a student group chartered by ASI.

Several distinguished speakers from around the state will be in San Luis Obispo for the week.

They include: George Fredrickson, professor of history at Stanford University; Patti Roberts, executive director for the National Center for Lesbian Rights; Delores Huerta, co-founder of the United Farm Workers; and Jan Marx and Diane Joyce, attorney and plaintiff in the U.S. Supreme Court case Johnson vs. Transportation Agency of Santa Clara (1987).

Also featured in the week's events is the City of San Luis Obispo's sexual harassment avoidance training class, which will take place Wednesday, May 15. The program, co-sponsored by the San Luis Obispo Human Relations Commission, will be held from 6 to 9 pm in the San Luis Obispo City Hall Council Room.

Currently, the Civil Rights Awareness Committee is composed of students who see the need to promote understanding and awareness of the nature of civil rights in the 1990s.

On Wednesday, May 15, Dr. Robert Gish, Cal Poly visiting scholar in ethnic studies, will discuss "Indigenous Rights of Native Americans" at 1 pm in UU Room 220. An hour later in the same location, Patti Roberts will explore "Lesbian and Gay Rights in the '90s."

On Friday, May 17, Delores Huerta will look at "Civil Rights

for Hispanics and Farm Workers: Is it the '30s or the '90s?" at 10 am in Chumash Auditorium. An hour later in the same location, George Fredrickson will discuss "Racism and Civil Rights in Comparative Perspective."

New Mexican potter to demonstrate work

Rosemary Apple Blossom Lonewolf, a potter from the Santa Clara Pueblo in New Mexico, will discuss and demonstrate her craft as the next speaker in the Arts and Humanities Lecture Series on Thursday, May 16.

She will talk about her work at 11 am in UU 220.

"Native Americans: Traditions and Culture in the Last Decade of the 20th Century" is the theme for this year's Arts and Humanities Lecture Series. It is sponsored by the School of Liberal Arts.

Following in the footsteps of her father, world-famous potter Joseph Lonewolf, Rosemary Lonewolf sets a contemporary style and grace to her pottery that has earned her a place among the very finest of American Indian artists.

Although her heritage is rich with a tradition of talented potters, she has taken her art in new directions. Her pots are a combination of the old and the new.

She forms her miniature pots from local Santa Clara clay using the ancient pinch or coil method. The dried pot is then layered with a watery slip of rich red clay. The surface is then polished to a brilliant, mirrored finish using a smooth stone. Next, she uses a stainless steel tool to etch the surface of the pot.

The next speaker in the series will be Joy Harjo, poet and professor of English at the University of New Mexico. She will be on campus on Thursday, May 23, to discuss "The Field of Miracles."

No advance sign-up or registration is required, although it is recommended that participants dress professionally and bring resumes. Many companies will be conducting on-the-spot interviews or will be scheduling interviews for the afternoon. Individual interviews, also to be held in Chumash, will be held from 1:30 to 4 pm.
