

LaSalle named Executive VP of Foundation

A widely known dairy scientist on the School of Agriculture faculty has been selected to head the Agricultural Education Foundation.

Appointment of Timothy J. LaSalle, as executive vice president of the foundation, which provides continuing education opportunities for California's future agriculture leaders, was jointly announced by Dean Brown, president of AEF, and President Baker.

LaSalle has been involved with AEF for several years, first as a participant in its Agricultural Leadership Program and more recently as director of its international study activity.

He will assume his new duties on July 1. He expects to retain his appointment as a member of the university faculty and will be on leave without pay while serving the foundation.

LaSalle is one of 43 outstanding young American professionals who were selected for the W.K. Kellogg Foundation's National Fellowship Program in 1984. He plans to continue his participation in that program through the conclusion of his commitment in August 1987.

ESRI founder will speak tonight

The founder and director of the Environmental Systems Research Institute will speak tonight (May 15) about the work his organization has done throughout the world using computers and satellites for analyzing and planning land areas.

Jack Dangermond is to begin his talk at 8 pm in the Gallery of

the Architecture and Environmental Design Building. The public is welcome. A donation will be requested at the door.

ESRI, based in Redlands, uses computers and satellite imagery to analyze areas as small as a neighborhood and as big as the Earth. The institute has been a national and international leader in developing systems for environmental analysis and geographic information.

The program is sponsored by the Landscape Architecture Department.

Swanson elected ASI president

Kevin Swanson, a senior mechanical engineering student, is the new president of the Associated Students Inc.

Elected by a margin of 14 percentage points over his opponent in a campus-wide run-off election held last week, he will assume the university's top student office with the start of the Summer Quarter on June 16.

The run-off between Swanson and Hammond became necessary when neither gained a clear majority in a special election involving seven candidates earlier this month.

That special election followed the annual spring election on April 16 and 17, after which the voting for president was invalidated when several candidates were charged with violations of campus election codes.

Elected during the spring election to serve as vice president of the student government was Stan Van Vleck, a junior majoring in agricultural management.

Dance Fest '86 set for May 17, 18

Dance companies from Cal Poly, San Luis Obispo County, and Santa Barbara will come together for Cal Poly's first invitational dance concert on Saturday and Sunday, May 17 and 18, in the Cal Poly Theatre.

Curtain time will be 8 pm on Saturday, and 2 pm on Sunday. Titled "Dance Fest '86," the concert is being co-sponsored by the Theatre and Dance Department and Orchesis Dance Co.

Representing San Luis Obispo will be Pat Jackson's American Dancers, the Civic Ballet of San Luis Obispo, San Luis Jazz Dancers, and San Luis Obispo's newest dance company, San Luis Civic Dance.

Dancers from Hancock College in Santa Maria will dance to the music of Aretha Franklin and the dancers from the Paso Robles School of Dance will dance to "Celebration" by Dvorak. In a lighter vein, Althea and Smitty Schmidt will provide a look at ballroom dancing when they do the cha cha.

Coming from Santa Barbara will be Repertory West Dance Co. performing groups.

The first string company will perform only on Saturday evening and will present "Songs for Chile," a piece choreographed for them by Lucas Hoving when he was their guest choreographer earlier in the year.

Repertory West II will appear in both shows with pieces choreographed by Nolan Dennett of UC Santa Barbara dance faculty.

Also appearing in the concert will be the Central Coast Jazz Co. and the Festival Ballet Co., both from Los Osos, and Dance For Joy from Arroyo Grande.

Steve Tsuruda, Bay Area graphic artist, will speak tonight (May 15) on "Architectural Graphics." The lecture will be at 7:30 pm in Room 225 of the Architecture and Environmental Design Building. Admission of \$1 includes a reception afterward.

The Beaux-Arts Ball on May 16 will be 8 pm to 1 am at the Camp San Luis Officers Club. 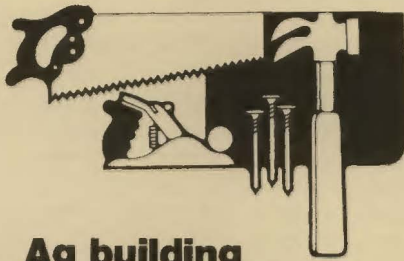

Ag building construction to begin Monday

Start of construction activity at the site of the new agricultural science building on the present site of the H-3 Parking Lot will require that persons who normally park there utilize other areas beginning on Monday, May 19.

E. Douglas Gerard, executive dean in charge of facilities planning, said closure of the H-3 lot and start of construction for the new building had been scheduled after the end of the Spring Quarter on June 16. Faster than expected processing of contracts for the work caused the change in start of the project, he added.

Suggested by Gerard as alternative parking locations for those displaced from the H-3 lot are lots H-14 near the OH Unit for both students and employees, and lots C-10 near Modoc Hall, H-6 near the Plant Operations and Receiving Warehouse Building on Truckee Rd., and spaces around the new Engineering Building for employees only.

Construction of the new agricultural science building, which will include classroom, laboratory, and faculty office spaces, is expected to take about 18 months.
