AG teachers conference

The 62nd annual conference of the California Agricultural Teachers Association (CATA) and annual Skills Week for teachers of vocational agriculture will be held June 22-27 at Cal Poly. The conference will run three days, June 22-24, to be followed by the skills portion, Thursday (June 25) through noon on Saturday (June 27). On Wednesday (June 24) the traditional Administrator's Lunch will be hosted by Cal Poly President, Warren J. Baker, and Dr. Howard Brown (Dean, School of Agriculture and Natural Resources).

The conference gets underway on Monday (June 22) and features regional meetings, alumni get-togethers, curriculum planning, and election of new officers during the three days. The Skills Week portion begins on Thursday (June 25) with 20 courses being offered to help vocational agriculture teachers improve their skills. Among the courses scheduled this year are hydraulics, basic and advance welding, fisheries management, forestry, horse production, and micro-computers.

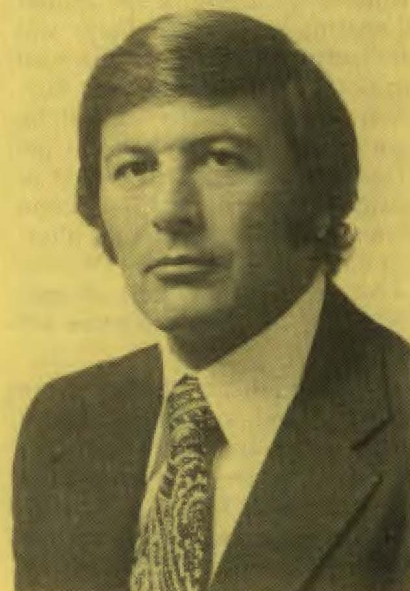
In addition, a four-day tour of Central Valley and San Francisco area cooperatives is being offered to CATA members on June 16-19 under sponsorship of the Agricultural Council of California.

HEATON APPOINTED ACTING ATHLETICS DIRECTOR

Richard Heaton (Associate Director of Intercollegiate Athletics) has been named acting director of intercollegiate athletics at the university. In making the announcement, President Warren J. Baker said that he has asked Heaton to serve on an interim one-year basis starting Sep. 1.

At that time, Vic Buccola, director of intercollegiate athletics for the past eight years, will return to full-time teaching in the university's Physical Education Department. Two months ago Dr. Buccola announced his request for reassignment.

A native of Waterloo, Iowa, Heaton earned an undergraduate degree in physical education at University of Northern Iowa. He was a two-time all-America wrestler at 157 pounds. While working on his master's degree in physical education at Cal Poly, he was an assistant wrestling coach. In 1970, he was named director of intramurals, and two years later he

became associate director of intercollegiate athletics. He is also on the university's physical education faculty.

Conference adjustments affect women's sports at Cal Poly

The California Collegiate Athletic Association's announcement that it is establishing competition for seven women's sports means that Cal Poly, San Luis Obispo, women's teams will be competing in a new conference starting this fall. Cal Poly women's teams will join those of the other CCAA-member institutions—Cal State, Bakersfield; Cal State, Northridge; Cal State, Los Angeles; Cal Poly Pomona; UC Riverside; Chapman; and Cal State, Dominguez Hills—in the new alignment.

Also announced today was the decision of Cal Poly, San Luis Obispo, to participate in National Collegiate Athletic Association post-season championships in women's sports. Vic Buccola (Director of Intercollegiate Athletics) said most of the teams competing against the university's women's teams will also participate in the NCAA post-season competition for women beginning this fall.

Cal Poly, San Luis Obispo, will continue its membership in the Association of Intercollegiate Athletics for Women (AIAW) and will use AIAW standards while competing in NCAA championships, Dr. Buccola added.

A recognition dinner for the Cal Poly men's basketball team, Division II, NCAA 3rd place finishers, is scheduled for Wednesday (May 27). The event will be held at the Veterans Memorial Building in San Luis Obispo. Social hour will begin at 6 pm, with dinner beginning at 7 pm. University Singers to perform

The University Singers, a 30-member vocal ensemble from Cal Poly, will present two performances of its annual Spring Concert on Saturday and Sunday (May 30 and 31). The first will be at 8 pm on Saturday (May 30) in the First United Methodist Church, 311 S. Broadway, Santa Maria. The second will begin at 3:30 the following afternoon in the United Methodist Church, 1515 Fredericks St., San Luis Obispo. Admission for both performances will be free.

James Dearing (Music) director of the mixed group and a member of Cal Poly's music faculty, said the program for the Spring Concert will feature the extensive Dvorak Mass in D, with organist David Locke. Soloists for the mass will be Ann Ross, soprano; Linda Tupac-Yupanqui, alto; John Sterne, tenor; and Robert DeVaughn, bass.

Other works on the program for the event include Renaissance motets by Victoria, Vulpus, Deering, and Billings. The University Singers choir has recently completed a tour during which it gave concerts at several of the missions in Northern California.

Government and happiness will be lecture topic

The responsibility of the government to keep its citizens happy will be the topic when Robert L. Bish gives the final Arts and Humanities Series lecture for 1980-81 on Thursday (May 28). titled "Can Government Provide Happiness?," Dr. Bish's presentation will begin at 11 am in University Union 220. Admission will be free and the public is invited to join members of the campus community in attending.

Currently on leave from the Institute for Urban Studies at University of Maryland, Dr. Bish is a visiting professor at University of Victoria in British Columbia. He will also discuss in his lecture how the relationship between the government and happiness has changed, in theory and practice, between 1776 and the present.

Distinguished in economics and public administration, Dr. Bish is the author of numerous books and articles on urban government and finance as well as coastal resource management. He earned his undergraduate degree at University of Southern California and his Ph.D. in economics at Indiana University. He has since taught at Universities of Washington, Southern California, Maryland, and Victoria.

Dennis Hawk ASI prexy

In a low 10 percent turnout, Cal Poly students elected Dennis Hawk president of the university's Associated Students Inc. by a two-to-one margin over opponent Stephanie Nelson. Hawk, a business administration major from Simi Valley, received 40 percent of the vote over Nelson's 28 percent in a field of four candidates in balloting on campus last week and since victory requires 50 percent plus one vote, a runoff election was held May 14 between the two top vote-getters. Hawk received 1,065 votes to Miss Nelson's 524 of 1,589 ballots cast. Cal Poly's current student enrollment is 15,588.

Trumpeter performs with Jazz bands

Trumpet and flugelhorn soloist Stu Blumberg will be the featured guest artist with the University Jazz Band during the "Jazz Nite" concert on Friday (May 29) at 8 pm in the Cal Poly Theatre. The show will also feature the Cal Poly Dixieland Bands, New Vintage jazz combo, and the San Luis Jazz dancers. Graydon Williams (Music) directs the University Jazz Band and Dixieland ensembles.

Blumberg is one of the West Coast's most outstanding young trumpet and flugelhorn soloists. Currently lead trumpet at the Shubert Theatre in Los Angeles, he is also the featured trumpet soloist with the Toshiko Akioishi-Lew Tabackin Big Band. Blumberg is a native of Detroit. He attended California State University, Northridge, and joined the Don Ellis band at age 19 and toured Europe with the group. His trumpet playing can be heard on five

albums with the Don Ellis band. Blumberg has also toured with Louie Bellson, Toshiko Akioishi, and the Osmonds.

The San Luis Jazz dancers are from the San Luis Academy of Dance. Led by Lori Lee Silvaggio, they will perform several dance selections with the jazz bands. Big band jazz, vintage jazz, modern jazz, and Dixieland sounds will be featured on the "Jazz Nite" program. The program will wind up with a Billy May jazz medley that will feature the University Jazz Band and the Dixieland ensembles with soloist Blumberg.

Reserved-seat tickets for "Jazz Nite" are on sale at the University Union ticket desk at \$4 for adults and \$2 for students. Tickets will be sold at the Cal Poly Theatre box office before the show. For ticket information and reservations, call Ext. 1421.



Poly women's track team tops

Cal Poly's women's track and field team tallied 69 points to win the university's first Association of Inter-collegiate Athletics for Women Division II National Championship on Saturday (May 16) at Indiana, Pa. Karin Smith, who won the javelin throw with a record-setting mark of 204 feet - 1½ inches, and Eileen Kramer, who won the 1500 meter run, led the charge for the Mustangs.

Finishing behind the Lance Harter-coached Cal Poly women were South Carolina State University with 51 points; University of Idaho, 50; Eastern Illinois University, 38; and California State College, Bakersfield, 36.

The Cal Poly men's track and field team continued its preparation for defense of the National Collegiate Athletic Association championship it won last year by winning the California Collegiate Athletic Association title on Saturday in Bakersfield. The Mustang men will enter the NCAA Division II meet on May 28-30, in Macomb, Ill., as favorites to return the national crown to San Luis Obispo.

Trustees receive honor

Four members of The California State University and Colleges Board of Trustees, including Chancellor Glenn S. Dumke and Charles Luckman, former Chairman of the Board, have been designated "Men of Achievement" in Los Angeles' current Bicentennial celebration. Chancellor Dumke was the only educator among 200 honorees at a major civic tribute April 25.

Trustee Luckman, FAIA, a member of the Board since 1960, was honored in the field of architecture. Governor Brown and Lt. Governor Mike Curb, ex-officio members of the Board of Trustees, were honored in the field of government. The Gala and Ball, conceived by Clive David, was attended by world-famous personages in virtually all professional and creative fields.

Albert C. Martin, Chairman of the Los Angeles 200 Committee, commented that "no record exists of any previous gathering with so prominent a cross-section of a community. It is doubtful that this can happen again."

Rape awareness program

As part of a program instituted by the CSUC Chancellor's Office, a program of rape prevention/awareness will be offered for Cal Poly faculty and staff members. Auxiliary organization employees as well as students are also invited to participate. Men and women are both welcome.

Developed by the Department of Public Safety in cooperation with the Personnel Office and various women's groups on campus, the program will be offered twice. Times in the University Union Mustang Lounge are from 10 am to noon on Tuesday, May 26 and from 1 pm to 3 pm on Wednesday (May 27).

The programs will cover various aspects of rape, and how to avoid and prevent it, "Legal and Moral Aspects of Rape," "Awareness and Prevention," "Self Defense," "The University and County Rape Protocol." There will be a film shown titled, "Rape, Escape Without Violence," and time for questions will be provided. Take away materials will also be distributed. President Warren J. Baker has authorized two hours of released time for those faculty and staff members who wish to attend.
