Cal Poly Named Best in the West for 21st Consecutive Year

Cal Poly has been rated the best public-master's university in the West in the U.S. News and World Report's 2014 America's Best Colleges guidebook — the 21st consecutive year the university has earned the label. Cal Poly ranked ninth in the magazine's overall list of the West's best universities, including both public and private institutions that provide "a full range of undergraduate and master's-level programs but few, if any, doctoral programs." President Armstrong Calls for More Access, Improved Graduation Rates, Professional Development for Faculty, and Improved Campus Climate



Cal Poly faculty and staff began the new academic year Monday with the kickoff to the university's annual Fall Conference, which precedes the start of classes on Sept. 23. Monday's activities included a state-of-the-university keynote address from President Jeffrey D. Armstrong, who welcomed faculty and staff to the new school year and outlined near-term strategic goals. Among his goals and initiatives, Armstrong announced that the university will investigate how it will increase enrollment to respond to California's need for more four-year college graduates.

"Enrollment growth is essential. California — really, the country — needs more Cal Poly graduates," Armstrong said. "However, the

extent, nature and timing of growth are questions that we need to investigate with all of Cal Poly's stakeholders — on campus and off campus. Armstrong also outlined four goals for the university to focus on this year and the next few years: improved graduation rates; further implementation of the teacher-scholar model; an enhanced campus climate; and increasing private support to strengthen Learn by Doing and sustain the university's national reputation for excellence.

Cal Poly to Help Launch New Model of Online Learning

Cal Poly is one of 15 higher education institutions participating in the launch of a new model of online learning through FemTechNet this fall. FemTechNet's Distributed Open Collaborative Course (DOCC) is a new approach to collaborative learning and an alternative to the massive open online course (MOOC) model that proponents claim will revolutionize 21st century higher education. The DOCC model is built on the understanding that expertise is distributed throughout a network of participants in diverse institutional contexts. This model explicitly departs from the typical MOOC approach organized around the delivery of information from an "expert" faculty (or a pair of instructors) to the "masses." Faculty members Jane Lehr and Helene Finger and ethnic studies alumna Beverley Kwang were recognized by the American Society of Engineering Education for their research into increasing the number of college women who enroll in engineering disciplines. The paper, titled, "When, Why, How, Who – Lessons from First-Year Female Engineering Students at Cal Poly for Efforts to Increase Recruitment," won the Best Zone Paper from the national organization. The paper is the result of an ongoing interdisciplinary collaboration between Cal Poly's Women's Engineering Program and the departments of Ethnic Studies and Women's and Gender Studies. Global Waste Research Institute Receives Keck Foundation Grant

A \$250,000 grant from the W.M. Keck Foundation will allow the Cal Poly Global Waste Research Institute (GWRI) to integrate new waste-related issues and environmental impacts related to nanotechnology into the school's broader undergraduate science, technology, engineering and math (STEM) curriculum. GWRI Director Nazli Yesiller said the funds, which follow a \$50,000 Keck Foundation planning grant, will affect a wide variety of courses and disciplines, both technical and non-technical. Warren DeLey

Warren DeLey, professor emeritus of sociology, passed away on Aug. 22. DeLey was a faculty of the Social Sciences Department from 1971 to 1997, acted as department chair from 1987 to 1993, and held the post of associate dean of the Division of Social Sciences from 1976 to 1980. Prior to joining Cal Poly, DeLey was the director of Institutional Studies at Sacramento State from 1967 to 1970. - Anthem Blue Cross is offering a new HMO plan for residents in Santa Barbara and San Luis Obispo counties.

Chancellor's Office to Support Campus Improvements

The CSU Chancellor's Office has agreed to fund nearly \$173,000 to replace campus street lighting with more energy-efficient LED lighting and upgrade the HVAC systems in Fisher Science (Bldg. 33). The new lighting will deliver a better spread of illumination and higher quality of light than current fixtures. In Fischer Science, aged mechanical equipment and controls will be replaced, resulting in energy savings and improved air quality.

HR Offers Update Regarding Defense of Marriage Act (DOMA) and Taxation

The Internal Revenue Service (IRS) has released Revenue Ruling 2013-17 on some of the federal tax issues regarding same-sex spouses under the U.S. Supreme Court's decision in *U.S. v. Windsor*. The IRS ruling states, a same-sex marriage is treated as valid for federal tax purposes if the individuals are lawfully married under state law or foreign law, even if the state in which they are domiciled does not recognize the validity of same-sex marriages. As a result of these recent IRS rulings, CSU employees with a same-sex spouse enrolled in their health and/or dental plan, will no longer incur an imputed tax. The IRS ruling is effective Sept. 16, 2013. Also, beginning Sept. 16, individuals may file amended tax returns and claims for refunds of overpayment of taxes provided the statute of limitations has not already expired. The statute of limitations for filing claims is generally three years from the date when the original return was filed, or two years from the date the tax was paid, whichever is later. Amended tax returns and claims for refunds may only be filed for tax years in which the individuals have a valid same-sex marriage, based on the state law or foreign law where they were lawfully married. We recommend employees consult with their tax advisors regarding filing amended tax returns. Please note this IRS ruling does not apply to registered domestic partners or civil unions.

ITS has found there is confusion about how long items are stored after they

have been moved to the Zimbra trash folder. The email support team consulted with various campus groups and received recommendations that automatic deletion should occur after 120 days, so they have established a new protocol effective with the start of fall quarter. Now, messages more than 120 days old will be automatically deleted. Users who have personal Gmail or Yahoo Mail accounts should already be familiar with the automatic deletion of older messages from the trash folder. This will be the same process for Zimbra. This automatic deletion will only affect the trash folder. If users wish to keep email for a longer period, they can move the message to a different email folder or leave it in their inbox. This will help make email more secure and reduce space and back-up requirements for the email system.
